I. INTRODUCTION

Board Certified Behavior Analysts (BCBAs) work to provide interventions in schools as well as working with families. It is common for BCBAs to develop support plans that facilitate academic and social success in multiple settings such as homes, schools, and the community. In order to be eligible to take the BCBA examination, a student must successfully complete a course sequence that has been verified by the Association for Behavior Analysis International. The Association for Behavior Analysis International has verified the following courses toward the coursework requirements for eligibility to take the Board Certified Behavior Analyst® or Board Certified Assistant Behavior Analyst® examination. Applicants will need to meet additional requirements before they can be deemed eligible to take the examination.

II. ADMISSION AND ENTRANCE REQUIREMENTS

New students should apply through Graduate Admissions for graduate non-degree status in the program. Applicants need an undergraduate degree within a related field and/or current graduate enrollment within a related field. A cumulative grade point average of 3.0 is required of all applicants. Related fields include but are not limited to: counseling, social work, school psychology, education, public health, and the behavioral sciences.
