## **A SALUTE TO RICHARD W. POGUE**

Richard W. Pogue's commitment to this community is illustrated by his active involvement in the business, education, social services, nonprofit and cultural sectors of greater Cleveland. If something important is happening in the region, you'll find Pogue at the heart of it.

In addition to the "In Tribute to the Public Service Award," Pogue has been honored with the "Torch of Liberty Award" from the Anti-Defamation League; the first annual "Economic Development Leadership Award" from the Council for Urban Economic Development (Washington); the "Humanitarian Award" from the National Conference of Christians and Jews; and the "Excellence in Philanthropy Award" from the Ohio Council of Fund Raising Executives, to name a few. He also was named "Outstanding Alumnus" by the University of Michigan Club of Cleveland; "Man of the Year" by Plymouth Church of Shaker Heights; and "Ohio Businessman of the Year" by Alpha Kappa Psi, Ohio State University.

He has served as Chair of many organizations, including The Cleveland Foundation, the Greater Cleveland Growth Association, University Hospitals Health System, the Greater Cleveland Roundtable, Cleveland Institute of Music, Cleveland Ballet, Cleveland Bicentennial Commission (Co-Chair), and the 13,500 member Antitrust Section of the American Bar Association. He also chaired the 1989 United Way campaign in Cleveland, which raised about \$52,000,000. He is a principal organizer of a new organization called Northeast Ohio Regional Business Coalition.

Pogue serves as a Director of Continental Airlines, Inc. (Houston), Derlan Industries Limited (Toronto), M.A. Hanna Company (Cleveland), IT Group, Inc. (Pittsburgh), KeyCorp (Cleveland), LAI Worldwide Inc. (New York City), Rotek Incorporated (Aurora) and TRW Inc. (Cleveland).

Born in Cambridge, Massachusetts, Pogue received a BA from Cornell University and a JD from the University of Michigan Law School. Upon retiring in 1994 as Senior Partner from Jones, Day, Reavis & Pogue (the country's second largest law firm, of which he was Managing Partner for nine years, 1984-92), Pogue joined Dix & Eaton as Senior Advisor. In 1993 and 1994 he taught a course as a Visiting Professor at Michigan Law School.

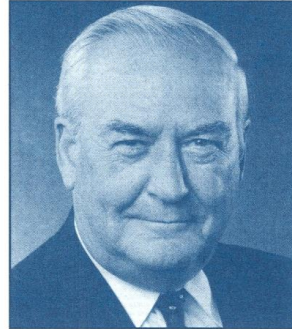
